On September 27, 2006, PAETEC Holding Corp. McLeodUSA Incorporated and McLeodUSA Telecommunications Services, Inc. ("Applicants") filed a joint Application ("Application") with the Arizona Corporation Commission ("Commission") in Docket No. T 03267A-07-0554 for approval to transfer indirect control of McLeodUSA Telecommunications Services, Inc. and for McLeodUSA Telecommunications Services, Inc. to participate in certain debt financing arrangements including encumbrance of its Arizona assets.

The Commission will consider the Application at an upcoming open meeting. The Application is available for inspection during regular business hours at the Commission's offices at 1200 West Washington Street, Phoenix, Arizona 85007, and at the office of McLeodUSA Incorporated, McLeodUSA Incorporated, 1 Martha's Way, Hiawatha, Iowa 52233.

Under appropriate circumstances, interested parties may intervene in the proceeding, and participate as a party. You may have the right to intervene in the proceedings, or you may make a statement for the record. Intervention shall be in accordance with A.A.C. R14-3-105. Persons desiring to intervene must file a written Motion to Intervene with the Commission and send such motion to the Company or its counsel and to all parties of record, and which at the minimum, shall contain the following:

The name, address, and telephone number of the proposed intervenor and of any party upon whom service of documents is to be made if different than the intervenor.

A short statement of the proposed intervenor's interest in the proceeding (e.g. a customer of the company, a shareholder of the company, a competitor, etc.). A statement certifying that a copy of the Motion to Intervene has been mailed to the Company or its counsel and to all parties of record in the case. Intervention shall be in accordance with A.A.C. R14-3105. If you have any comments, mail them to: The Arizona Corporation Commission, Attention: Docket Control, Re: PAETEC Holding Corp., McLeodUSA Incorporated and McLeodUSA Telecommunications Services, Inc., Docket No. T-03267A-07-0554, 1200 West Washington, Phoenix, Arizona 85007.





