PROCEDURAL ORDER

BY THE COMMISSION:

On October 30, 2007, the Arizona Corporation Commission ("Commission") issued an Order to Show Cause directing Total Call International, Inc. ("Company") to appear before the Commission to explain why, among other things, it failed to comply with certain terms of Decision No. 64065 dated October 4, 2001, granting the Company a Certificate of Convenience and Necessity. It also was ordered that the Hearing Division schedule further appropriate proceedings.

On December 13, 2007, a telephonic Procedural Conference was held in this docket. Present at the telephonic Procedural Conference were representatives of the Company and the Commission's Utility Division Staff ("Staff").

The parties indicated that they wish to enter into negotiations to arrive at a possible settlement in this matter.
