PROCEDURAL ORDER

BY THE COMMISSION:

On December 28, 2005, Palo Verde Utilities Company ("Palo Verde") and Santa Cruz Water Company ("Santa Cruz") filed an application with the Arizona Corporation Commission ("Commission") for an extension of their Certificates of Convenience and Necessity ("Certificate") in Docket Nos. SW-03575A-05-0926 and W-03576A-05-0926.

On March 29, 2006, Arizona Water Company ("AWC") filed an application with the Commission to extend its Certificate in Docket No. W-01445A-06-0199. On this same day, AWC

1 requested to intervene in Docket Nos. SW-03575A-05-0926 and W-03576A-05-0926. AWC's
2 request for intervention was granted by procedural order on April 12, 2006.

3 On May 17, 2007, Santa Cruz Water Company, L.L.C., and Palo Verde Utilities Company,
4 L.L.C. (collectively "Global Utilities") filed with the Arizona Corporation Commission
5 ("Commission") an application to extend their respective Certificates of Convenience and Necessity
6 ("CC&N") in Pinal County, Arizona.

7 On July 17, 2007, AWC filed a Motion to Consolidate ("Motion") Docket Nos. W-01445A-
8 06-0199, SW-03575A-05-0926, W-03576A-05-0926, SW-03575A-07-0300 and W-03576A-07-0300.

9 On August 20, 2007, Global filed its response to the Motion.

10 On September 21, 2007, Staff filed its response to the Motion.

11 On November 26, 2007, a Procedural Conference was held in Docket Nos. SW-03575A-07-
12 0300 and W-03576A-07-0300.

13 IT IS THEREFORE ORDERED that Docket Nos. W-01445A-06-0199, SW-03575A-05-
14 0926, W-03576A-05-0926, SW-03575A-07-0300 and W-03576A-07-0300 are hereby consolidated.

15 IT IS FURTHER ORDERED that the Ex Parte Rule (A.A.C. R14-3-113 - Unauthorized
16 Communications) applies to this proceeding and shall remain in effect until the Commission's
17 Decision in this matter is final and non-appealable.

18 IT IS FURTHER ORDERED that the Presiding Officer may rescind, alter, amend, or waive
19 any portion of this Procedural Order either by subsequent Procedural Order or by ruling at hearing.
