PROCEDURAL ORDER

BY THE COMMISSION:

On February 1, 2006, WorldxChange Corp. ("Company") filed correspondence with the Arizona Corporation Commission ("Commission") requesting that its Certificate of Convenience and Necessity ("CC&N") be cancelled.

On February 10, 2006, the Commission's Utilities Division Staff ("Staff") filed its Letter of Insufficiency and First Set of Information Requests ("Data Requests"). The Company did not respond to the Data Requests.

On September 24, 2007, a Procedural Order was issued requesting Staff to file an update on the status of this matter by October 31, 2007.

On October 4, 2007, Staff resent the Data Requests to the Company.


On October 31, 2007, Staff filed a Staff Update recommending that if the Company failed to respond to the Data Requests by November 4, 2007, the Company's Certificate should be cancelled.

As of the date of the Staff Update, there have been no actions or additional filings in this docket indicating whether the Company has responded to the Data Requests. As such, Staff should file a Staff Report supporting its recommendation that the Certificate be cancelled.


