PROCEDURAL ORDER

BY THE COMMISSION:

On November 16, 2007, the Securities Division ("Division") of the Arizona Corporation Commission ("Commission") filed a Temporary Order to Cease and Desist and Notice of Opportunity for Hearing ("Notice") against Ronald James Strayer (a/k/a RJ Strayer), and Jane Doe Strayer, husband and wife, Jeffrey Stanford Ryan and Lisa Scott, husband and wife, and RJSR Land Development CR, a Costa Rican corporation (collectively "Respondents") in which the Division alleged multiple violations of the Arizona Securities Act ("Act") in connection with the offer and sale of securities in the form of stock.

The Respondents were duly served with a copy of the Notice.

On December 6, 2007, a request for hearing was filed by the Respondents.

On December 7, 2007, by Procedural Order, a pre-hearing conference was scheduled for January 17, 2008.

On January 14, 2007, the Division filed a Motion to Continue ("Motion") the pre-hearing conference pending Commission approval of a proposed Consent Order at its next regularly scheduled Open Meeting on Securities matters.

1 Accordingly, the Division's Motion is reasonable and the pre-hearing conference should be
2 vacated.

3 IT IS THEREFORE ORDERED that the pre-hearing conference scheduled on January 17,
4 2008, at 9:30 a.m., is hereby vacated.

5 IT IS FURTHER ORDERED that if the Consent Order is not approved by the Commission,
6 the Division shall file a Motion for the scheduling of a status conference.
