**REQUEST TO EXTEND DEADLINE
FOR FILING COMMENTS ON STAFF
REPORT AND REQUEST TO
CONTINUE HEARING DATE**

On December 21, 2007, Staff filed a Request for an Extension of Time requesting a three-week extension of the deadline for filing the Staff Report in this docket from December 21, 2007 to January 11, 2008. Applicant Broadweave Networks of Arizona ("Broadweave") supported Staff's request, and in a Procedural Order dated December 24, 2007, the Commission's administrative law judge ("ALJ") granted Staff's request and extended the deadline for filing comments regarding the Staff Report from January 14, 2008 to January 18, 2008. Broadweave's time for filing comments to the Staff Report was shortened significantly from 24 days to only seven days in order to preserve the original hearing date of January 23, 2008.

After reviewing the Staff Report and certain recommendations contained therein, Broadweave has determined that it will need additional time to file its written comments regarding the Staff Report. This delay will necessitate a short continuance of the hearing date currently set for January 23, 2008. Accordingly, Broadweave requests that the deadline for filing disagreements/comments regarding the Staff Report be extended three weeks to **Friday, February 8, 2008**. Broadweave further requests that the hearing date be reset for a date and time convenient to the hearing division on or after **Tuesday, February 19, 2008**. Broadweave has discussed this request with Staff, and Staff has


