IN THE MATTER OF THE APPLICATION OF TOWER CLOUD, INC. FOR APPROVAL OF A CERTIFICATE OF CONVENIENCE AND NECESSITY TO PROVIDE INTRASTATE TELECOMMUNICATIONS SERVICES INCLUDING FACILITIES-BASED LOCAL EXCHANGE TELECOMMUNICATIONS SERVICES.

On November 1, 2007, Tower Cloud, Inc. ("Tower" or "Company") submitted to the Arizona Corporation Commission ("Commission") an application for a Certificate of Convenience and Necessity ("Certificate") to provide facilities-based local exchange telecommunications services. The Commission's Utilities Division ("Staff") has recommended approval of the Company's application. The Commission is not

bound by the proposals made by the Company, Staff, or any intervenors, and the Company will be required to provide this service under the rates and charges and terms and conditions established by the Commission. Copies of the application, report of Staff, and any written exceptions to the report of Staff filed by the Company will be available at the Company's offices, 9501 International Court N., St. Petersburg, FL 33716 and on the internet via the Commission's website (www.azcc.gov) using the e-docket function.

The Commission will hold a hearing on this matter beginning April 15, 2008, at 10:00 a.m., at the Commission's offices, Hearing Room 100, 1200 West Washington, Phoenix, AZ. Public comments will be taken on the first day of the hearing. Written public comments may be submitted via email (visit <http://www.azcc.gov/utility/cors/index.htm> for instructions), or by mailing a letter referencing Docket Number T-20563A-07-0627 to: Arizona Corporation Commission, Consumer Services Section, 1200 West Washington, Phoenix, AZ 85007.

The law provides for an open public hearing at which, under appropriate circumstances, interested parties may intervene. Intervention shall be permitted to any person entitled by law to intervene and having a direct and substantial interest in the matter. Persons desiring to intervene must file a written motion to intervene with the Commission up to the day of the hearing. The motion to intervene must be sent to the Company or its counsel and to all parties of record, and must contain the following:

1. The name, address, and telephone number of the proposed intervenor and of any party upon whom service of documents is to be made if different from the intervenor;
2. A short statement of the proposed intervenor's interest in the proceeding (e.g., a customer of the Company, a shareholder of the Company, etc.); and
3. A statement certifying that a copy of the motion to intervene has been mailed to the Company or its counsel and to all parties of record in the case.

The granting of motions to intervene shall be governed by A.A.C.R14-3-105, except that all motions to intervene must be filed on or before March 24, 2008. If representation by counsel is required by Rule 31 of the Rules of the Arizona Supreme Court, intervention will be conditioned upon the intervenor obtaining counsel to represent the intervenor. The granting of intervention, among other things, entitles a party to present sworn evidence at hearing and to cross-examine other witnesses.
