PROCEDURAL ORDER

BY THE COMMISSION:

On March 22, 2007, the Arizona Corporation Commission ("Commission") issued Decision No. 69386 approving the application of Arizona Water Company ("Arizona Water" or "Company") for an extension of its water Certificate of Convenience and Necessity ("Certificate" or "CC&N").

Pursuant to Decision No. 69386, AWC was required to file the following:

1. a copy of the first Approval to Construct for facilities needed to serve the requested areas issued by the Arizona Department of Environmental Quality, within one year of the effective date of the Decision.
2. a copy of the first developer's Certificate of Assured Water Supply ("CAWS") for the extension area, within one year of the effective date of the Decision.

On January 9, 2008, the Company filed the first Approval to Construct for facilities needed to serve the requested area. In the same filing, the Company requested an extension of time, until March 22, 2009, to file a copy of the first developer's CAWS.

On February 15, 2008, Staff filed a memorandum stating that Staff had no objection to Arizona Water's request for additional time to comply with the CAWS requirement, but recommended that no further extensions of time be granted.

IT IS THEREFORE ORDERED that Arizona Water's request for an extension of time until March 22, 2009, to file a copy of the first developer's Certificate of Assured Water Supply, is hereby granted.


