On September 28, 2000, Arizona Electric Division of Citizens Communications Company ("Citizens") filed an application to change the current Purchased Power and Fuel Adjustment Clause Rate, to establish a new Purchased Power and Fuel Adjustment Clause Bank, and to request approved guidelines for the recovery of costs incurred in connection with energy risk management initiatives.

On October 10, 2000, the Arizona Utility Investors Association, Inc. ("AUIA") filed a Motion for Leave to Intervene.
