PROCEDURAL ORDER

**BY THE COMMISSION:**

On April 26, 2006, Verizon California, Inc. ("Company"), filed with the Arizona Corporation Commission ("Commission") its Petition for Competitive Classification of Proposed National Directory Assistance and Customer Name and Address Service ("Petition").

On May 25, 2006, the Company filed an Affidavit of Publication indicating that legal notice of the Petition had been published on May 10, 2006 in the *Parker Pioneer*.

On May 11, 2007, the Company filed a Notice of Change of Counsel.

On November 8, 2007, a Procedural Order was issued directing the Commission's Utilities Division Staff ("Staff") to provide a status update on this docket.

On December 21, 2007, the Company filed correspondence requesting withdrawal of its Petition ("Withdrawal Request"). The Company noted that it will continue to provide national directory assistance and customer name and address service to its customers.

On January 16, 2008, Staff filed its Staff Update and Administrative Closure ("Update"). In the Update, Staff noted that on October 18, 2007 it sent to the Company correspondence regarding certain Staff concerns surrounding the Company's request to establish new pricing. As a result, Staff requested that the Company file a separate petition regarding the requested rate change. However, the Company did not file a new petition, but rather, filed its Withdrawal Request.

Staff had no objections to the Company's request and recommended that this docket be administratively closed.

1 Accordingly, the Company's Petition is withdrawn and Docket No. T-01846B-06-0282 shall  
2 be administratively closed.

3 IT IS THEREFORE ORDERED that Verizon California, Inc.'s Petition for Competitive  
4 Classification of Proposed National Directory Assistance and Customer Name and Address Service,  
5 **Docket No. T-01846B-06-0282**, is hereby administratively closed.


