PROCEDURAL ORDER

BY THE COMMISSION:

On December 27, 2007, the Securities Division ("Division") of the Arizona Corporation Commission ("Commission") filed a Temporary Order to Cease and Desist ("T.O.") and a Notice of Opportunity for Hearing ("Notice") against Ferenc J. Csampai and Jane Doe Csampai, husband and wife, individually and d/b/a Global Aviation Fuel Systems ("GAFS") and Robert N. Neklewicz a/k/a Robert Neil Stock and Jane Doe Neklewicz, husband and wife, individually and d/b/a GAFS (collectively "Respondents"), in which the Division alleged that the Respondents committed multiple violations of the Arizona Securities Act ("Act") in connection with the offer and sale of securities in the form of investment contracts.

Respondents were duly served with copies of the Notice.

On February 4, 2008, Respondent, Robert N. Neklewicz, filed a request for hearing and his Answer.

Accordingly, a pre-hearing should be scheduled.

IT IS THEREFORE ORDERED that a **pre-hearing conference** shall be held on **February 27, 2008, at 10:30 a.m.** at the Commission's offices, 1200 West Washington Street, Hearing Room

1, Phoenix, Arizona.

IT IS FURTHER ORDERED that if Respondent, Robert N. Neklewicz, wishes to appear telephonically, he shall contact the Commission's Hearing Division at (602) 542-4250 at least three days prior to the pre-hearing for instructions how to appear telephonically.
