**REQUEST FOR ADDITIONAL
EXTENSION OF DEADLINE FOR
FILING COMMENTS ON STAFF
REPORT AND REQUEST TO
CONTINUE HEARING DATE**

On January 17, 2007, Broadweave Networks of Arizona ("Broadweave") filed a request to (i) extend the deadline for filing disagreements/comments regarding the December 21, 2007 Staff Report in this case; and (ii) extend the hearing date. Broadweave made the request to allow additional time to raise and address with Staff certain questions and concerns regarding recommendations contained in the Staff Report. In a Procedural Order dated January 18, 2008, the Commission's Administrative Law Judge granted Broadweave's request and established a new procedural schedule. Since the date of the Procedural Order, representatives of Broadweave met with members of Utilities Division Staff to discuss the Staff recommendations. From Broadweave's perspective, the meeting was helpful in understanding the bases underlying certain Staff recommendations and Broadweave believes that additional discussions with Staff will narrow any disputed issues between Staff and Broadweave with respect to Broadweave's application and Staff's recommendations. Accordingly, Broadweave requests that the deadline for filing disagreements/comments regarding the Staff Report be extended 60 days from the current due date of February 8, 2008, to Tuesday, April 8, 2008. Broadweave further requests that the hearing date currently scheduled for February 28, 2008, be reset for a

1 date and time convenient for the hearing division on or after Monday, April 28, 2008.
2 Broadweave has discussed this request with Staff, and Staff has no objection to the
3 proposed new filing deadline and hearing date.
