PROCEDURAL ORDER

BY THE COMMISSION:

On December 31, 2007, the Securities Division ("Division") of the Arizona Corporation Commission ("Commission") filed a Notice of Opportunity for Hearing ("Notice") against Rick McCullough d/b/a McCullough Insured Investments, The Kodiak Investment Group, L.L.C. ("Kodiak"), and Anita Geneva McCullough a/k/a Anita G. Maestas (collectively "Respondents") in which the Division alleged multiple violations of the Arizona Securities Act ("Act") in connection with the offer and sale of securities in the form of promissory notes.

The Respondents were duly served with copies of the Notice.

On January 18, 2008, a request for hearing was filed by Anita G. McCullough.

On January 28, 2008, by Procedural Order, a pre-hearing conference was scheduled on February 14, 2008.

On February 8, 2008, a request for hearing and an Answer was filed by Rick McCullough.

Accordingly, the pre-hearing conference should be held as previously scheduled.
