Dear Mr. Grant:

On January 18, 2008, SBC Long Distance, LLC d/b/a AT&T Long Distance and SBC Long Distance ("SBC LD") filed an application to discontinue the provision of local exchange and private line services for business customers in Arizona. The application is not yet sufficient. This data request lists the information Staff needs to complete its analysis of your application. Please consider this as Staff's first set of data requests to SBC LD in the above-referenced matter.


For purpose of this data request set, the words "SBC LD", the "Company", "you", and "your" refer to SBC Long Distance, LLC d/b/a AT&T Long Distance and SBC Long Distance and any representative, including every person and/or entity acting with, under the control of, or on behalf of SBC Long Distance, LLC d/b/a AT&T Long Distance and SBC Long Distance. For each answer, please identify by name, title, and address each person providing information that forms the basis for the response provided. These data requests are continuing, and your answers or any documents supplied in response to these data requests should be supplemented with any additional information or documents that come to your attention after you have provided your initial responses.

Please provide Docket Control with the information being requested within 10 days of the date of this letter. Please mail an original plus 13 copies to: Docket Control, Arizona Corporation Commission, 1200 W. Washington Street, Phoenix, Arizona 85007. If no response is received or all deficiencies are not remedied within 30 days, Staff will recommend that the application be terminated pursuant to A.A.C. R14-2-1103(B)3 and A.A.C. R14-2-510(E)3. If the application is terminated, the Applicant cannot discontinue the telecommunication services it is authorized to provide in the state of Arizona, until such time as a new application is filed with and approved by the Commission.

Please make certain that each numbered item and each part of the item is answered completely. In order for Staff to continue with its review of this application, the following information must be submitted:

- CLA 1-1 Please provide the current number of customers that SBC is providing service to as of January 31, 2008.
- CLA 1-2 For the 67 business customers referenced in this application, please provide:
- a.) The total local exchange revenue for the full-year 2007.
  - b.) The total number of access lines served at year-end 2007.
- CLA 1-3 Will SBC LD transfer a business customer's local exchange service to its affiliate AT&T Communications of the Mountain States, Inc. if the customer fails to switch to another carrier?
- CLA 1-4 If your response to CLA 1-3 is in the affirmative, does SBC LD intend to request a limited waiver of A.A.C. R14-2-1901, *et seq.*, Consumer Protection for Unauthorized Carrier Changes?
- CLA 1-5 Does the Applicant have any employees in Arizona? If so, please list the number of employees by type of category (i.e. management, technical, and customer service). If this application is approved by the Commission, will there be any layoffs of SBC LD employees in Arizona? If so, please explain.
- CLA 1-6 Did the Applicant have any service contracts with customers? If so, please describe how the service contracts were honored or terminated with the customers.
