PROCEDURAL ORDER

BY THE COMMISSION:

On January 10, 2008, the Securities Division ("Division") of the Arizona Corporation Commission ("Commission") filed a Notice of Opportunity for Hearing ("Notice") against Donna Marie Shurot, (the "Respondent") in which the Division alleged multiple violations of the Arizona Securities Act ("Act") in connection with the unauthorized transfer of funds from customers' accounts into Respondent's personal accounts.

The Respondent was duly served with a copy of the Notice.

On February 12, 2008, the Respondent filed an answer ("Answer") with the Commission.

A review of the Notice and Answer indicates that a pre-hearing conference would be beneficial.


Accordingly, a pre-hearing conference should be scheduled.


