On April 12, 2006, the Commission entered Decision No. 68654 in the above-captioned docket. Decision No. 68654 (the "Decision") approved the Company's application for an extension of its certificate of convenience and necessity for its Casa Grande system. It also contained the following ordering paragraphs, at page 8, lines 1-16 of the Decision:

IT IS FURTHER ORDERED that Arizona Water Company shall file with Docket Control, as a compliance item in this docket, copies of the Arizona Department of Environmental Quality's Approval to Construct for facilities needed to serve the requested transfer areas within two years of the effective date of the Decision in this Order.

1 IT IS FURTHER ORDERED that Arizona Water Company shall file with  
2 Docket Control, as a compliance item in this docket, a Notice of filing indicating  
3 Arizona Water Company has submitted for Staff's review and approval, a copy  
4 of the fully executed main extension agreements for water facilities for the  
5 requested transfer areas within two years of the effective date of the Decision in  
6 this Order.

7  
8 IT IS FURTHER ORDERED that that Arizona Water Company shall file  
9 with Docket Control, as a compliance item in this docket, a copy of the  
10 developers' Certificate of Assured Water Supply for the requested transfer areas  
11 where applicable or when required by statute, within two years of the effective  
12 date of the Decision in this Order.

14 The Company is requesting that the current compliance deadline, April 12, 2008, be  
15 extended for an additional two (2) year period, until April 12, 2010. In support of its request, the  
16 Company respectfully provides as follows:



20 b. The Company is submitting as Attachments 2, 3, 4, and 5 hereto letters from the  
21 current property owners of the majority of the owners of the real property in the

24 plans to develop its/their property and still needs and desires to receive water
