MOTION TO MODIFY PUBLIC NOTICE


On March 14, 2008, a Procedural Order was issued which set forth the procedural schedule applicable to the Section 40-252 Hearing to consider changes to the Paradise Valley Water District's rate design. The Order also required the Company to send a notice to customers advising them of the hearing and its purpose. The notice contained in the Order tells interested members of the public requiring assistance to call the Consumer Services Section of the Commission at its toll-free telephone number. This telephone number will not work, however, for local calls including calls from Paradise Valley residents who are most likely to have an interest in this matter. For this reason, the Staff requests a modification to the notice contained in the Procedural Order to list the local telephone number for the Consumer Services Section or Commission as well, for residents within the Phoenix Metropolitan calling area. The Commission/Consumer Services Section local telephone number is (602) 542-4251. This change should be made to the notice where it appears on page 6 of the Order, line 13. Staff proposes the following language in place of the last sentence under the


