COX ARIZONA TELCOM's RESPONSE

TO STAFF MOTION FOR IN CAMERA INSPECTION

Cox Arizona Telcom, LLC ("Cox") hereby responds to Staff's Motion for In Camera Inspection of Documents Claimed to be Attorney-Client Privileged (filed on February 13, 2008). Cox continues to believe that an in camera review is premature pending a ruling on the legal issue concerning the Staff's assertion that Cox has waived the attorney-client privilege. However, without waiving any rights now or in the future (including Cox's position that it has not waived the attorney-client privilege in this docket), Cox states that it will comply if the ALJ orders an in camera review of the documents referenced in the Staff's exhibit to its motion. In such event, Cox requests a three-week period to compile and submit those documents for in camera review.
