FINDINGS OF FACT

1. Diversified Water Utilities, Inc. ("Company") is certificated to provide water as a public service corporation in the State of Arizona.
2. On March 7, 2008, the Company requested that its Hook-Up Fee Tariff Schedule be terminated.
3. According to the Company, it is in the best interest of Diversified and its customers to terminate its Hook-Up Fee and operate under the Commission's long standing main extension agreement rule (Arizona Administrative Code R14-2-406).
4. Staff needs additional time to review and analyze the data provided by the Company on March 7, 2008.
5. Staff has recommended that the Commission suspend this filing for a period of 120 days, through and including July 15, 2008.
