PROCEDURAL ORDER
(Vacate Pre-Hearing Conference)

BY THE COMMISSION:

On January 10, 2008, the Securities Division ("Division") of the Arizona Corporation Commission ("Commission") filed a Notice of Opportunity for Hearing ("Notice") against Donna Marie Shurot, (the "Respondent") in which the Division alleged multiple violations of the Arizona Securities Act ("Act") in connection with the unauthorized transfer of funds from customers' accounts into Respondent's personal accounts.

The Respondent was duly served with a copy of the Notice.

On February 12, 2008, the Respondent filed an answer ("Answer") with the Commission.

On February 27, 2008, a Procedural Order was issued setting pre-hearing conference in this docket for April 1, 2008 at 10:00 a.m.

On March 12, 2008, the Division filed a proposed Order to Cease and Desist, Order of Revocation and Consent to Same ("Order") by Respondent Donna M. Shurot, CRD # 1443423.

On March 27, 2008, at the time and place set for the Commission's Open Meeting on the matter, the Commission approved the proposed Order.

Accordingly, the pre-hearing conference currently scheduled for April 1, 2008 should be vacated.
