PROCEDURAL ORDER

BY THE COMMISSION:

On March 20, 2008, the Arizona Corporation Commission ("Commission") issued Decision No. 70194 in the above-captioned matter. Decision No. 70194 ordered the Commission's Utilities Division to prepare a Notice of Proposed Rulemaking to adopt Net Metering Rules, A.A.C. R14-2-2301 through R14-2-2308 ("Proposed Net Metering Rules") and forward it to the Arizona Secretary of State for publication in the *Arizona Administrative Register*. Decision No. 70194 further ordered the Commission's Hearing Division to schedule a public comment proceeding on the Proposed Rulemaking to be held no earlier than 30 days after publication in the *Arizona Administrative Register*, but as soon as practicable thereafter.

IT IS THEREFORE ORDERED that, in accordance with A.R.S. § 41-1023, an oral proceeding to obtain public comments on the Proposed Net Metering Rules shall be held on June 5, 2008, at 10:00 a.m., at the Commission's offices located at 1200 West Washington, Hearing Room 1, Phoenix, Arizona.

IT IS FURTHER ORDERED that the Utilities Division shall cause a Notice of Proposed Rulemaking, including the oral proceeding public comment date, time, and location set forth above, to be published in the *Arizona Administrative Register* no later than April 18, 2008.

IT IS FURTHER ORDERED that the Utilities Division shall include the following statements in the Notice of Proposed Rulemaking:

- 1. That written comments on the Notice of Proposed Rulemaking will be accepted through June 5, 2008;

2. That written comments on the Notice of Proposed Rulemaking should include a reference to Docket No. RE-00000A-07-0608 and should be submitted to the Commission's Docket Control; and
3. That, although written comments will be accepted through June 5, 2008, the Commission requests that interested persons file initial written comments on the proposed rules on or before May 19, 2008, and file any written comments in response to other interested persons' comments on or before May 27, 2008.

IT IS FURTHER ORDERED that the Utilities Division shall:

1. Ensure that any written comments submitted to the Utilities Division rather than the Commission's Docket Control are promptly filed with Docket Control; and
2. On or before June 2, 2008, file with Docket Control the Utilities Division's written comments, including any additional recommendations, in response to any comments filed by interested persons.

IT IS FURTHER ORDERED that the Presiding Officer may rescind, alter, amend, or waive any portion of this Procedural Order either by subsequent Procedural Order or by ruling at hearing.


