PROCEDURAL ORDER

BY THE COMMISSION:

On February 1, 2006, Telefyne Incorporated ("Telefyne"), through its attorney, filed a letter requesting to cancel its Certificate of Convenience and Necessity ("CC&N") to provide competitive resold long distance telecommunications services and alternative operator services.

On February 10, 2006, Staff issued a letter of insufficiency and data request to Telefyne's attorney.

No further filings were made in this docket between February 10, 2006, and September 13, 2007.

On September 13, 2007, a Procedural Order was issued requiring Staff to file an update in this matter, with any appropriate recommendations, by October 4, 2007.

On October 2, 2007, Staff issued another letter of insufficiency and data request to Telefyne's attorney.

On October 3, 2007, Staff issued another letter of insufficiency and data request, directly to Mr. Chris Bellas at Telefyne.

On October 4, 2007, Staff filed an Update, stating that Staff had received an e-mail from the assistant to Telefyne's attorney explaining that the attorney is no longer working with Telefyne in this matter. Staff stated that it then sent a copy of the letter of insufficiency and data request directly to Telefyne by certified mail, but had not yet received a response. Staff recommended that the matter

1 not be administratively closed.

2 Nothing has been filed in this docket since Staff's Update.

3 Thus, it is appropriate for Staff to make a filing updating the Commission on the status of this
4 matter and providing any appropriate recommendations.

5 IT IS THEREFORE ORDERED that Staff shall file an **update** on this matter, with any
6 appropriate recommendations, by **April 23, 2008**.


