BY THE COMMISSION:

On January 25, 2008, the Securities Division ("Division") of the Arizona Corporation Commission ("Commission") filed a Notice of Opportunity for Hearing ("Notice") against Scott Hutchinson and Jane Doe Hutchinson, as husband and wife, and d/b/a Marine 3, (collectively, the "Respondents") in which the Division alleged multiple violations of the Arizona Securities Act ("Act") in connection with the unauthorized sale of stock while engaging in fraudulent activity connected to the sale of stock.

The Respondents were duly served with a copy of the Notice.


On March 31, 2008, the Respondent filed an answer ("Answer") with the Commission and requested a hearing.


