**PROCEDURAL ORDER**

15 **BY THE COMMISSION:**

16 On January 7, 2008, the Staff of the Utilities Division of the Arizona Corporation  
17 Commission ("Staff") filed with the Arizona Corporation Commission ("Commission") a Complaint  
18 ("Complaint") against Cienega Water Company, Inc. ("Respondent").

19 On April 3, 2008, a Pre-Hearing Conference was held, during which the parties agreed to  
20 enter into discussions about the resolution of the Complaint.

21 On May 2, 2008, a Pre-Hearing Conference was held during which Staff requested that a  
22 hearing date be set.

23 Accordingly, a hearing should be scheduled.

24 IT IS THEREFORE ORDERED that a **hearing shall be held on August 5, 2008, at 10:30**  
25 **a.m.**, at the Commission's office, 1200 West Washington Street, Room 100, Phoenix, Arizona.

26 IT IS FURTHER ORDERED that Respondent shall file with Docket Control a copy of a  
27 **Corporate Resolution authorizing Eleanor Stephan to represent the Respondent for the**  
28 **purposes of these proceedings by June 16, 2008.**

IT IS FURTHER ORDERED that **Staff shall file testimony and exhibits** to be used at the  
hearing by **July 8, 2008.**

IT IS FURTHER ORDERED that **Respondents shall file testimony and exhibits** to be used

1 at the hearing by July 31, 2008. Respondent may consult with Staff regarding the preparation  
2 and filing of testimony.

3 IT IS FURTHER ORDERED that the ex parte rule (A.A.C. R14-3-113—Unauthorized  
4 Communications) applies to this proceeding and shall remain in effect until the Commission's  
5 Decision in this matter is final and non-appealable.

6 IT IS FURTHER ORDERED that all parties must comply with Rules 31 and 38 of the Rules  
7 of the Arizona Supreme Court and A.R.S. § 40-243 with respect to the practice of law and admission  
8 *pro hac vice*.


