



Patrick Quinn, of lawful age being first duly sworn, deposes and states:

1. My name is Patrick Quinn. I am State President-Arizona of Qwest Corporation in Phoenix, Arizona.
2. In compliance with Arizona Corporation Commission Decision No. 64654 granting limited waiver of rule R-14-2-803, I hereby swear and affirm that during the twelve month period preceding the date of this affidavit there were no transactions of Qwest Corporation (QC), Qwest Communications Corporation (QCC), their parent Qwest Communications International, Inc. (QCII) or any of their affiliates, which intended to organize or reorganize the public utility holding company which would have 1) resulted in increased capital costs to QC; 2) resulted in additional costs allocated to the Arizona jurisdiction; or 3) resulted in a reduction of QC's net operating income.
3. Attached is a listing of organization/reorganization activities that occurred during the prior 12 month period for which Qwest did not file a notice of intent pursuant to the waiver granted in Decision No. 64654 and which did not result in 1) increased capital costs to QC; 2) additional costs allocated to the Arizona jurisdiction; or 3) a reduction of QC's net operating income.
