Public Notice of Filing of Approval to Encumber Assets in Connection with New Financing by DIECA Communications, Inc. d/b/a Covad Communications Company
Docket No: T-03632A-08-0113
 DIECA Communications, Inc. d/b/a Covad Communications Company ("Covad" or "Applicant") filed an application with the Arizona Corporation Commission ("Commission") on February 27, 2008, asking for authorization to provide its guarantee, encumber assets, or to otherwise provide security in connection with financing of up to \$285 million entered into by Applicant's parent company, Covad Communications Group, Inc. ("CCGI"). The Application is available for inspection during regular business hours at the office of the Commission located at 1200 West Washington Street, Phoenix, Arizona 85007; and at the office of Applicants' legal counsel, Osborn Maledon PA, 2929 N. Central Ave., Suite 2100, Phoenix, AZ 85012. Intervention in the Commission's proceedings on the application shall be permitted to any person entitled by law to intervene and having a direct substantial interest in this matter. Persons desiring to intervene must file a Motion to Intervene with the Commission which must be served upon applicant and which, at a minimum, shall contain the following information:

(1) the name, address and telephone number of the proposed intervenor and of any person upon whom service of documents is to be made if different than the intervenor; (2) a short statement of the proposed intervenor's interest in the proceeding; (3) whether the proposed intervenor desires a formal evidentiary hearing on the application and the reasons for such a hearing; and (4) a statement certifying that a copy of the Motion to Intervene has been mailed to Applicant.

The granting of Motions to Intervene shall be governed by A.A.C. R14-3-105, except that all Motions to Intervene must be filed on, or before, the 15th day after this notice.



