CLARIFICATIONS TO THE RECOMMENDED OPINION AND ORDER

On April 22, 2008, the Hearing Division of the Arizona Corporation Commission ("ACC") issued a Recommended Opinion and Order ("ROO") regarding the instant application. ACC Utilities Division Staff ("Staff") hereby provides the following clarifications to the ROO.

- On page 4, line 19 1/2, the word "time" should be changed to "item."
- On page 8, line 11, the word "Staff" should be changed to "ADWR."
- On page 19, lines 6 through 8, the ordering paragraph describing Staff's recommended capital structure should be revised to include the phrase "no debt" as follows:

OLD LANGUAGE: . . . Double Diamond Utilities, Inc. shall obtain Staff's recommended capital structure of approximately 70 percent equity, and 30 percent advances in aid of construction . . ."

NEW LANGUAGE: . . . Double Diamond Utilities, Inc. shall obtain Staff's recommended capital structure of no debt, approximately 70 percent equity, and 30 percent advances in aid of construction . . ."

- On page 21, line 26 3/4 and page 22, line 16 3/4, the service charge descriptions entitled "Main Extensions/Meter Relocation" shown should be changed to "Meter Relocation."


Main extensions are not tariff items and must be submitted to the Arizona Corporation Commission for review and approval per Rule R14-2-406.
