Dear ALJ Farmer:

I know that this letter is a bit out of the ordinary, but given our time frame and the need to receive Commission approvals we wanted to propose some time frames on behalf of Salt River Project Agricultural Improvement and Power District ("SRP").

Here is SRP's concept, which could take the form of a procedural order:

- April 30: Form of notice for the public open house to the Hearing Division for approval, along with the proposed mailing list
- May 9: Form of notice approved by the Hearing Division and date of open house set (suggest May 20) and date of hearing set (suggest May 30)
- May 12: Open house notice mailed to mailing list
- May 20: Open house at the Pinal County Fairgrounds, probably 7 p.m. (so that lack of AC will not be an issue, the facilities do have evaporative cooling)
- May 30: Approximate date for hearing (we will need an actual date to put in the public notice) and possible Commission decision following evidentiary presentation
- June 16: Recommended opinion and order issued, if the Commission does not issue a decision at the hearing
- July 1: Place on Commission open meeting agenda for a decision, if the Commission does not issue a decision at the hearing.
