REQUEST FOR EXTENSION OF TIME TO FILE STAFF REPORT

On February 15, 2008, Del Rio Water Company ("Del Rio") filed an application before the Arizona Corporation Commission ("ACC") requesting extension of service area under its current Certificate of Convenience and Necessity ("CC&N").

On April 21, 2008, ACC Utilities Division Staff ("Staff") filed a Sufficiency Letter in this docket.

On April 29, 2008, the ACC Hearing Division issued a Procedural Order directing Staff to file its Staff Report on or before May 20, 2008. That same Procedural Order set hearing in this matter on June 9, 2008, with notice of hearing to be published no later than May 19, 2008.

It is Staff's understanding that publication has not yet been accomplished.

Unfortunately, assigned Staff has become unforeseeably unavailable. Currently Staff has no indication as to the exact time for a return to work. Even absent this misfortune, it would have been very difficult for Staff to complete the Staff report within the abbreviated time frame. Given this development, the Staff report simply can not be completed in time.

WHEREFORE, Staff hereby requests that the Hearing Division grant an extension of time to file the Staff report in this matter until June 30, 2008.

Staff further requests that the hearing currently scheduled be vacated and reset to a time consistent with the filing of the Staff Report.
