**STAFF'S REQUEST FOR AN
EXTENSION OF TIME**

On May 23, 2007, Picacho Peak Water Company, Inc. ("Picacho") filed with the Arizona Corporation Commission ("ACC") an application requesting authority to incur debt to finance water system improvements ("Finance Application"), in Docket No. W-02351A-07-0686.

On December 13, 2007, Picacho filed with the ACC an application for a rate increase in Docket No. W-02351A-07-0686.

On January 29, 2008, Picacho filed a request to consolidate the two dockets. There was no opposition to the request and on February 11, 2008, ACC Hearing Division ordered the matters to be consolidated.

In accordance with the requirements of the Arizona Administrative Code, R14-2-103(B)(7), on March 20, 2008, ACC Utilities Division Staff ("Staff") sent Picacho a letter indicating that the applications were sufficient. Pursuant to this same rule, Staff classified Picacho as a Class "D" company. Therefore, pursuant to R14-2-103(B)(11)(B), Staff is required to file its Staff report within 75 days of sufficiency. Therefore, Staff is required to file its Staff Report in the instant matter no later than May 15, 2008.

Unfortunately, due to Staff's extremely heavy caseload, Staff is unable to produce the Staff Report within the normal time frame. Staff believes it will be able to file the Staff Report no later than May 21, 2008.

1 WHEREFORE, Staff respectfully requests that the Hearing Division grant an extension of
2 time until May 21, 2008 to file the Staff Report.


