PROCEDURAL ORDER

BY THE COMMISSION:

In Decision No. 69381 (March 22, 2007), the Arizona Corporation Commission ("Commission") approved the application of Lucky Hills Water Co. ("Lucky Hills" or "Company") to extend its Certificate of Convenience and Necessity ("CC&N"). In the Decision, the Commission ordered Lucky Hills to file a copy of the Approval of Construction for a new 2,000 gallon storage facility within a year of the date of the Decision, or March 22, 2008.

On March 21, 2008, Lucky Hills requested a six month extension of the deadline. In its request the Company reports that it has ordered the storage tank but that as of the date of its request, the tank had not been delivered and the consequently, the Approval of Construction has not been received from the Arizona Department of Environmental Quality ("ADEQ").

The Commission's Utilities Division ("Staff") should file a response to the Company's request for extension, indicating Staff's recommendation to the Commission.

IT IS THEREFORE ORDERED that **Staff shall file a response** to Lucky Hills request by **June 16, 2008**. Staff's filing shall include Staff's recommendation to the Commission regarding the Company's request.


