To the Arizona Corporation Commission:

This firm represents Time Warner Telecom of Arizona LLC ("Time Warner Telecom" or "the Company") in Arizona. By way of this letter, Time Warner Telecom respectfully advises the Arizona Corporation Commission that it has changed its name to **tw telecom of arizona llc**. There will be no change in control, operations or management of the Company. Time Warner Telecom, now known as **tw telecom**, will continue to offer the same services at the same rates, terms and conditions as at present.

The Company hereby requests that all of its records on file with the Commission be changed to reflect this new name. Attached hereto as Exhibit A is a copy of the Certificate of Amendment of Time Warner Telecom adopting the new name, **tw telecom of arizona llc**. Attached as Exhibit B, is the Articles of Amendment regarding the name change filed with Corporations Division of the Arizona Corporation Commission.

Customers were provided a written notice of the name change by notice dated March 12, 2008. All required documents have been filed with the Secretary of State. We will be filing tariffs with the Arizona Corporation Commission reflecting our new name on or about June 16, 2008. Upon review of Arizona statutes and Commission regulations, it is our understanding that Commission approval is not required for a simple name change. Should the Commission believe that any other action is required, we respectfully request that the Commission notify the undersigned at its earliest


