**STAFF'S MOTION TO
RESET HEARING DATE**

On March 28, 2008, Vernon Valley Water, Inc. ("VVW") filed an application before the Arizona Corporation Commission ("ACC") requesting an extension of its Certificate of Convenience and Necessity ("CC&N") to provide water service within Apache County, Arizona.

Pursuant to A.A.C. R14-2-103(B)(7) and R14-2-411(C), on April 28, 2008, ACC Utilities Division Staff ("Staff") issued notice to VVW that its application had met the sufficiency requirements of A.A.C. R14-2-103.

On April 29, 2008, the ACC Hearing Division issued a Procedural Order setting hearing in this matter for June 30, 2008, at 10 a.m.


Unfortunately, both the Staff members necessary for the instant matter and Staff's assigned counsel are assigned to a separate matter before the ACC which is currently set to proceed on the same day and at the same time- Farmers Water Company, Docket No. W-01654A-07-0603.

Since the substitution of both Staff and counsel would be very difficult to manage in the short time frame, Staff believes it is necessary to vacate the current hearing date and reset the hearing to a later date.

WHEREFORE, Staff respectfully requests that the hearing currently scheduled in this matter be vacated and that a new hearing date be scheduled.
