
NOTICE OF DECISION OF

17 **NOTICE IS HEREBY GIVEN** that on this date, the Colorado Public Utilities
18 Commission (the "Colorado Commission") denied Qwest Corporation's Application for
19 Rehearing, Reargument or Reconsideration of the Colorado Commission's Initial Decision in
20 Docket No. 07B-514T (the "Application"). At the request of the Administrative Law Judge
21 herein, Arizona Dialtone, Inc. ("AZDT") filed the Colorado Commission's Initial Decision as a
22 late-filed exhibit on May 9, 2008. Thereafter, on May 12, 2008, Qwest filed its Application with
23 this Commission. Finally, on May 21, 2008, AZDT filed its Response to Qwest's Application
24 with this Commission as Exhibit A to its Post-Hearing Brief. In light of these prior filings
25 regarding the parallel proceedings between the parties before the Colorado Commission, AZDT
26 advises this Commission of the ruling on Qwest's Application.

1 The Colorado Commission has not yet issued its written decision denying Qwest's
2 Application, but AZDT will file that written decision with this Commission upon receipt.


