PROCEDURAL ORDER

**BY THE COMMISSION:**

On May 23, 2007, Picacho Peak Water Company, Inc. ("Picacho" or "Company") filed with the Arizona Corporation Commission ("Commission") an application for authority to incur debt to finance water system improvements under Docket No. W-02351A-07-0319.

On December 13, 2007, Picacho filed with the Commission an application for a rate increase under Docket No. W-02351A-07-0686.

Pursuant to a Procedural Order issued February 11, 2008, Docket Nos. W-02351A-07-0319 and W-02351A-07-0686 were consolidated.

On March 20, 2008, the Commission's Utilities Division Staff ("Staff") notified Picacho that its applications were sufficient as of February 28, 2008. Staff is required pursuant to Arizona Administrative Code R14-2-103(B)(11)(B) to file its Staff Report within 75 days of a sufficiency finding—in this case, no later than May 15, 2008.

On May 13, 2008, Staff filed its Request for an Extension of Time, stating that because of Staff's heavy caseload, Staff is unable to meet the deadline. As such Staff requested an extension of time to file its Staff report from May 15, 2008 to May 21, 2008.

Staff related to the Hearing Division that it had contacted the Company and it had no objection to the extension.

IT IS THEREFORE ORDERED that Staff's Motion for an Extension is hereby granted.

1 IT IS FURTHER ORDERED that the Staff Report shall be filed on or before 4:00 p.m., May  
2 21, 2008.

3 IT IS FURTHER ORDERED that the time clock for issuing a Decision in this matter is  
4 extended accordingly.


