**STAFF'S MOTION TO WITHDRAW ITS  
REQUEST TO  
RESET HEARING DATE**

On March 28, 2008, Vernon Valley Water, Inc. ("VVW") filed an application before the Arizona Corporation Commission ("ACC") requesting an extension of its Certificate of Convenience and Necessity ("CC&N") to provide water service within Apache County, Arizona.

Pursuant to A.A.C. R14-2-103(B)(7) and R14-2-411(C), on April 28, 2008, ACC Utilities Division Staff ("Staff") issued notice to VVW that its application had met the sufficiency requirements of A.A.C. R14-2-103.

On April 29, 2008, the ACC Hearing Division issued a Procedural Order setting hearing in this matter for June 30, 2008, at 10 a.m.

On May 16, 2008, Staff filed a motion requesting that the June 30, 2008 hearing be rescheduled due to a conflict in the schedules of the Staff witnesses and counsel involved. It now appears that there is no conflict on the intended hearing date.

WHEREFORE, Staff respectfully *withdraws* its request to reschedule the June 30, 2008 hearing.
