PROCEDURAL ORDER

BY THE COMMISSION:

On September 18, 2006, Zeus Telecommunications, LLC ("Applicant" or "Zeus") submitted to the Arizona Corporation Commission ("Commission") an application for a Certificate of Convenience and Necessity ("Certificate") to provide resold long distance telecommunications services within the State of Arizona.

On January 3, 2007, the Commission's Utilities Division Staff ("Staff") filed a Letter of Insufficiency and its First Set of Data Requests in this docket.

To date, Applicant has not responded to Staff's Data Requests and there have not been any other filings in this matter. Accordingly, Staff should make a filing updating the Commission on the status of this matter.

**IT IS THEREFORE ORDERED that Staff shall file an update on Zeus' application along with any appropriate recommendations no later than August 18, 2008.**

IT IS FURTHER ORDERED that the Presiding Office may rescind, alter, amend, or waive any portion of this Procedural Order either by subsequent Procedural Order or by ruling at hearing.
