Dear Mr. Marcus:

On July 19, 2004, ComTech21, LLC d/b/a ComTech2 ("ComTech21") and United Systems Access Telecom, Inc. ("USAT") filed with the Commission a notification of a transfer of USAT's customer base to ComTech21. On August 17, 2004, ComTech21 requested a waiver of the Commission's Slamming and Cramming rules as it relates to the transfer of USAT's customers to ComTech21. On September 30, 2004, USAT filed a letter with the Commission stating that ceased doing business in Arizona and requested that its authority to provide telecommunications services be cancelled. On March 29, 2005, a Procedural Order was issued to consolidate the Docket Numbers listed above. The Application submitted is not sufficient. This data request lists the information Staff needs to complete its Staff Report.

For purposes of this data request set, the word "ComTech21" refers to ComTech21, LLC d/b/a ComTech21, any representative, including every person and/or entity acting with, under the control of, or on behalf of ComTech21, LLC d/b/a ComTech2. Also, the word "USAT" refers to United Systems Access Telecom, Inc., any representative, including every person and/or entity acting with, under the control of, or on behalf of United Systems Access Telecom, Inc. **For each answer, please identify by name, title, e-mail address, telephone number and address each person providing information that forms the basis for the response provided.**

These data requests are continuing, and your answers or any documents supplied in response to these data requests should be supplemented with any additional information or documents that come to your attention after you have provided your initial responses. Also, please make sure all information you provide in response to item(s) concerning this Application, including Staff's data requests, is updated and current. If you need to update your response to any item(s)/request(s), please reference the item(s)/request(s) and provide your current response(s).

Please provide Docket Control with the information being requested within **10 days** of the date of this letter. Mail an Original plus 17 copies to Docket Control, Arizona Corporation



JFB4-1. Please provide a copy of the legal notice of the Application to cancel telecommunications services in all counties affected by the Application. Refer to Arizona Administrative Code ("A.A.C.") Rule R14-2-1107.

JFB4-2. In USAT's Response to Staff's First Set of Data Requests Item No. 1, USAT reported that it provided service to customers Arizona. In addition, USAT stated that it discontinued providing service in June 2004 and that 104 of its residential customers were transferred to ComTech21. Refer to USAT's Response to Staff's First Set of Data Requests Item No. 5 and Item No. 6 respectively.

- a. If customers are not currently being served in Arizona, please provide an affidavit to that effect.
- b. If service is currently provided to customers in Arizona, please provide the number of residential and business customers.
- c. Did USAT have any service contracts with customers? If yes, please describe how the service contracts were honored.

JFB4-3. In USAT's Response to Staff's First Set of Data Requests Item No. 7, USAT reported that ComTech21 notified USAT's customers by letter that ComTech21 will be their service provider. A copy of ComTech21's letter dated July 22, 2004 states that as of September 15, 2004, USAT's customers will begin receiving services from ComTech21.

- a. Please confirm that USAT transferred 104 of its customers to ComTech21 in June 2004 before the 104 residential customers were informed in July that their service will be provided by ComTech21 as of September 15, 2004.
- b. If the response to JFB4-3a. is no, please explain. Refer to A.A.C. Rule R14-2-1107.

JFB4-4. Please indicate the state(s) in which USAT currently operates.

JFB4-5. Does USAT have any employees in Arizona? If yes, please provide the number of employees.
