

PROCEDURAL ORDER

BY THE COMMISSION:

By Procedural Order dated May 12, 2008, the Hearing Division of the Arizona Corporation Commission ("Commission") set this matter for hearing to commence on July 9, 2008, and established a procedural schedule for the filing of testimony.

On May 29, 2008, the Commission's Utilities Division ("Staff") filed a Settlement Agreement entered into between Tucson Electric Power Company ("TEP"), Arizonans for Electric Choice and Competition and Phelps Dodge Mining Company collectively ("AECC"); Arizona Community Action Association ("ACAA"); U.S. Department of Defense and all other Federal Executive Agencies ("DOD"); Arizona Investment Council ("AIC"); International Brotherhood of Electrical Workers Local 1116 ("IBEW Local 1116"); mesquite Power, LLC, Southwestern Power Group II, LLC, Bowie Power Station, LLC, and Sempra Energy Solutions, LLC ("Power Producers"); the Kroger Company and Staff.

On June 11, 2008, IBEW Local 1116 filed a Motion for an Enlargement of Time in which to file its testimony in support of the Settlement Agreement. IBEW Local 116's counsel's schedule has


1 not allowed him to complete the required testimony by June 11, 2008, its due date. IBEW Local 116
2 requests an extension until June 19, 2008 to file its testimony in support of the Settlement Agreement.

3 IBEW Local 1116 reports in its Motion that the Residential Utility Consumer Office, the only
4 party on record as opposing the Settlement Agreement, does not object to the requested extension.
5 IBEW Local 1116 served a copy of its Motion electronically, and no parties have objected.

6 Given the lack of opposition the one-week extension is not unreasonable and should not
7 prejudice any other party.

8 IT IS THEREFORE ORDERED that IBEW Local 1116's Motion for an extension of time to
9 file its testimony in support of the Settlement Agreement until no later than June 19, 2008, is granted.


