Dear Mr. Campbell:

On February 12, 2008, Curatel, LLC ("Curatel") filed an Application for a Certificate of Convenience and Necessity ("CC&N") to provide facilities-based local exchange, resold local exchange, resold long distance, and facilities-based long distance telecommunications services within the State of Arizona. The Application is not yet sufficient. This data request lists the information that Staff needs to complete its analysis of the Application. Please treat this as Staff's First Set of Data Requests to Curatel, LLC in the above matter.

For purposes of this data request set, the words "Curatel", "Applicant", "the Company", "you", and "your" refer to Curatel, LLC and any representative, including every person and/or entity acting with, under the control of, or on behalf of Curatel. For each answer, please identify by name, title, and address each person providing information that forms the basis for the response provided.

These data requests are continuing, and your answers or any documents supplied in response to these data requests should be supplemented with any additional information or documents that come to your attention after you have provided your initial responses.

Please provide Docket Control with the information being requested within **30 days** of the date of this letter. Mail an original plus 13 copies to Docket Control, Arizona Corporation Commission, 1200 W. Washington Street, Phoenix, AZ 85007-2927. If no response is received, Staff will recommend that the Application be terminated. If the Application is terminated, the Applicant cannot provide the same telecommunications services in Arizona for which it is currently applying, until such time as a new Application is filed with and approved by the Commission.

- PJG 1-4 Besides Mr. Daniel Magolis, as listed in item A-19 of Curatel's Application, please identify any other management employees of Curatel by employee's name, title, position, description of their work experience, and years of service in the telecommunications services industry.
- PJG 1-5 Please describe Curatel's plan for providing customer service to its customers in Arizona?
- PJG 1-6 Is Curatel planning to have a customer service center in Arizona?
- PJG 1-7 Is Curatel planning to have employees in Arizona? If so, please indicate how many.

Staff has located several errors/inconsistencies within the recurring and non-recurring rates for the following business custom calling features: Selective Call Forward, Call Trace – Law Enforcement, and Call ID and Call Name Delivery.
- PJG 1-12 Are the basic residential effective rates for Usage Based IntraLATA Toll Service for rate zone 3 and IntraLATA shown on Original Sheet No. 108 of Curatel's proposed Arizona C.C. Tariff No. 1 correct in comparison to the minimum and maximum rates shown on Original Sheet No. 66? If not, please file corrected replacement pages.

- PJG 1-15 Please review, make appropriate corrections, and file replacement tariff pages for either Original Sheet No. 81 and/or Original Sheet No. 116 to Curatel's proposed Arizona C.C. Tariff No. 1. Staff has identified a minimum and maximum service charge for 'Jack, each jack' on Original Sheet No. 81 but there is not an effective rate listed for the same service on Original Sheet No. 116.
