AMENDED MOTION TO EXTEND TIME TO FILE STAFF REPORT

On February 8, 2008, Bellemont Water Company ("Applicant") filed before the Arizona Corporation Commission ("ACC") an application for a rate increase.

On April 7, 2008 and April 25, 2008, Applicant amended the application. ACC Utilities Division Staff ("Staff") reviewed the amended applications and on May 12, 2008 found them to be sufficient pursuant to Arizona Administrative Code R-14-2-103.B.7. Staff classified the Applicant as a Class E utility. Along with the Sufficiency Notification, Staff sent its first Data Request.

Response to the May 12, 2008 Data Request was expected on or before May 22, 2008, but Staff did not receive a response until June 2, 2008. In order to have enough time to review and process the response, Staff will need 10 additional days in which to prepare the Staff Report.

Staff had previously believed that the Staff Report was due to be filed on or before July 8, 2008 pursuant to Arizona Administrative Code R-14-2-103.B.11. However, the proper calculation would make the Staff Report in this matter due to be filed on or before July 11, 2008. Nonetheless, due to the unexpected departure of the Staff member previously assigned to this application and the subsequent reassignment of the matter, Staff still needs the ten additional days in order to properly review the analysis which has been performed to date and to complete any unfinished analysis.

On June 6, 2008, Staff filed a motion to extend the time to file its Staff Report. However, Staff had not contacted the Applicant to discuss the extension. Staff has since contacted the Applicant and avows that the Applicant has stated that it does not object to the requested 10-day extension of time.

1 WHEREFORE, Staff respectfully requests that the due date for the Staff Report be extended
2 From July 11, 2008 until July 21, 2008.
