PROCEDURAL ORDER

BY THE COMMISSION:

On March 20, 2001, the Securities Division ("Division") of the Arizona Corporation Commission ("Commission") filed a Notice of Opportunity for Hearing Regarding Proposed Order to Cease and Desist, for Restitution, for Administrative Penalties and for Other Affirmative Action ("Notice") against Early Detection Centers, Inc. ("EDC"), Johnathon Roberts, Inc. ("JRI"), David Hitzig and Paul C. Woodcock in which the Division alleged multiple violations of the Arizona Securities Act ("Act") in connection with the offer and sale of securities in the form of investment contracts.

The Respondents were duly served with a copy of the Notice.

On April 2, 2001, Respondents Hitzig and Woodcock filed a request for hearing.

Accordingly, a pre-hearing conference should be scheduled to address the issues raised in the Notice and the presentation of evidence.
