NOTIFICATION OF INTERVENTION

BY THE COMMISSION:

In Decision No. 68826 (June 29, 2006), the Arizona Corporation Commission ("Commission") approved the sale and transfer of assets, and cancellation of Certificates of Convenience and Necessity ("CC&N"), of Miracle Valley Water Company, Cochise Water Company, Horseshoe Ranch Water Company, Crystal Water Company, Mustang Water Company, Coronado Estates Water Company and Sierra Sunset Water Company (collectively "McLain Water

1 Systems”) to Northern Sunrise Water Company and Southern Sunrise Water Company (collectively
2 “Applicants”).

3 In Decision No. 68826 the Commission acknowledged that the McLain Water Systems might
4 be serving customers outside of their certificated boundaries and that it might make sense for
5 Applicants to extend their CC&N boundaries to include these customers as well as other properties
6 that are reasonable and logical. The Commission ordered the Applicants to file by December 31,
7 2007, “applications for approval to extend their CC&Ns to areas being served outside of the CC&N
8 approved in this case.”

9 On January 3, 2008, Applicants filed a “Compliance with Decision No. 68826.” By their
10 filing, Applicants seek to amend their CC&Ns pursuant to Decision No. 68826.


11 By undated letter, docketed with Docket Control on June 9, 2008, Jeffrey and Marlene
12 McDaniel, current customers of Southern Sunrise Water Company, requested intervention in this
13 matter in order to protect their ability to have a private well in the future.

14 No party objected to the requests to intervene.

15 The Applicants’ request to extend their CC&Ns should not have an effect on a property
16 owner’s ability or right to utilize a private well. Therefore, the request to intervene will be granted
17 with the proviso that the issues before the Commission as a result of the application will not be
18 unduly broadened.

19 IT IS THEREFORE ORDERED that the request to intervene filed by Mr. and Mrs. McDaniel
20 is granted as discussed above.


