**BY THE COMMISSION:**

On January 28, 2008, Union Pacific Railroad Company ("Railroad") filed with the Arizona Corporation Commission ("Commission") an application for authority to alter the public at-grade crossing at Ruthrauff Road, AAR/DOT No. 741 104C ("Application").

On March 12, 2008, at a related procedural conference on the Railroad's double track project, the Railroad agreed to request a procedural conference be scheduled for future scheduling on its Application as related cases were heard and Decisions issued by the Commission.

On June 9, 2008, the Railroad filed a request that a procedural conference be set to discuss scheduling issues in this docket.

Accordingly, a procedural conference should be scheduled to discuss possible hearing and filing dates.
