10 **BY THE COMMISSION:**

11 On January 17, 2008 Union Pacific Railroad Company ("Railroad") filed with the Arizona
 12 Corporation Commission ("Commission") an application for authority to alter the public at-grade
 13 crossings at Camino de Manana Road, AAR/DOT No. 741 097U, Massingale Road, AAR/DOT No.
 14 741 100A, and Joiner Road, AAR/DOT No. 741 341N ("Application").

15 On March 12, 2008, at a related procedural conference on the Railroad's double track project,
 16 the Railroad agreed to request a procedural conference be scheduled for future scheduling on its
 17 Application as related cases were heard and Decisions issued by the Commission.

18 On June 9, 2008, the Railroad filed a request that a procedural conference be set to discuss
 19 scheduling issues in this docket.

20 Accordingly, a procedural conference should be scheduled to discuss possible hearing and
 21 filing dates.


