PROCEDURAL ORDER

11 BY THE COMMISSION:

12 On May 23, 2007, Picacho Peak Water Company, Inc. ("Picacho" or "Company") filed with  
13 the Arizona Corporation Commission ("Commission") an application for authority to incur debt to  
14 finance water system improvements under Docket No. W-02351A-07-0319.

15 On December 13, 2007, Picacho filed with the Commission an application for a rate increase  
16 under Docket No. W-02351A-07-0686.

17 Pursuant to a Procedural Order issued February 11, 2008, Docket Nos. W-02351A-07-0319  
18 and W-02351A-07-0686 were consolidated.

19 On March 20, 2008, the Commission's Utilities Division Staff ("Staff") notified Picacho that  
20 its applications were sufficient as of February 28, 2008. Staff is required pursuant to Arizona  
21 Administrative Code R14-2-103(B)(11)(B) to file its Staff Report within 75 days of a sufficiency  
22 finding—in this case, no later than May 15, 2008.

23 On May 13, 2008, Staff filed its Request for an Extension of Time to file its Staff report from  
24 May 15, 2008 to May 21, 2008.

25 Staff's request was granted pursuant to a Procedural Order dated May 19, 2008.

26 Staff filed its Staff Report May 21, 2008.

27 On May 30, 2008, the Company filed its Request for an Extension of Time to File Comments  
28 to Staff Report from June 2, 2008 to June 9, 2008. Staff did not object to the Company's extension

1 request.

2 The Company's request was granted pursuant to a Procedural Order dated June 5, 2008.

3 On June 9, 2008, the Company filed its Comments on Staff Report ("Comments"). In its  
4 Comments, the Company proposed an alternate rate structure, among other things. In order to issue a  
5 Recommended Opinion and Order in this matter, it is necessary for Staff to file a response to the  
6 Company's Comments.

7 IT IS THEREFORE ORDERED that Staff shall file a response to the Company's Comments  
8 on or before **4:00 p.m., August 8, 2008.**

9 IT IS FURTHER ORDERED that the time clock for issuing a Decision in this matter is  
10 extended accordingly.


