17 **FINDINGS OF FACT**

18 1. FERENC ("Frank") J. CSAMPAI ("CSAMPAI") is an individual residing in Las
19 Vegas, Nevada, and was, during all relevant times, Director of Maintenance for GLOBAL
20 AVIATION FUEL SYSTEMS ("GAFS").

21 2. CSAMPAI was, at all relevant times, an unmarried man.

22 3. From October 2007 to December 2007, CSAMPAI had been offering an investment
23 opportunity to the general public by advertising on an internet website known as Craig's
24 List/Phoenix ("Craig's List"). CSAMPAI represented that investors could earn up to 80% return
25 on their investment with no risk. CSAMPAI also represented that the investments were
26 guaranteed.

RECOMMENDED ORDER

3 THEREFORE, on the basis of the Findings of Fact and Conclusions of Law, the
4 Commission finds that the following relief is appropriate, in the public interest, and necessary for
5 the protection of investors:

6 IT IS ORDERED, pursuant to A.R.S. §44-2032, that CSAMPAI, and any of CSAMPAI's
7 agents, employees, successors and assigns, permanently cease and desist from violating the
8 Securities Act.
