18 Procedural Conference.


19 Eschelon Telecom of Arizona, Inc. ("Eschelon") requests a continuation of the  
20 conference until Thursday, September 4, 2008 (or such other date in September as the  
21 Commission orders) due to scheduling conflicts. Eschelon also requests the parties be allowed to  
22 participate by telephone to reduce expenses associated with travel.

23 Eschelon has conferred with counsel for Qwest. Qwest indicated that it has no objection  
24 to continuing the conference until **Thursday, September 4, 2008.**<sup>1</sup> Qwest also indicated that it  
25 has no objection to the parties' appearing telephonically.
