PROCEDURAL ORDER

22 **BY THE COMMISSION:**

23 On July 3, 2008, the Securities Division ("Division") of the Arizona Corporation Commission
24 ("Commission") filed a Notice of Opportunity for Hearing ("Notice") against Mark W. Bosworth and
25 Lisa A. Bosworth, husband and wife; Stephen G. Van Campen and Diane V. Van Campen, husband
26 and wife; Michael J. Sargent and Peggy L. Sargent, husband and wife; Robert Bornholdt and Jane
27 Doe Bornholdt, husband and wife; Mark Bosworth & Associates, LLC ("MBA"); and 3 Gringos
28 Mexican Investments, LLC ("3GMI") (collectively "Respondents"), in which the Division alleged
multiple violations of the Arizona Securities Act ("Act") in connection with the offer and sale of
securities in the form of notes and investment contracts.

Respondents were duly served with copies of the Notice.

On July 24, 2008, Respondents Michael J. and Peggy L. Sargent filed a request for a hearing.

1 On July 28, 2008, Respondents Michael W. and Lisa A. Bosworth and MBA filed a request
2 for hearing.

3 On August 1, 2008, a notice of appearance was entered by counsel on behalf of Respondent
4 Robert Bornholdt. A request for hearing has yet been filed pursuant to A.R.S. § 44-1972 and A.A.C.
5 R14-4-306.

6 Accordingly, a pre-hearing conference should be held on the allegations contained in the
7 Notice.

8 IT IS THEREFORE ORDERED that a **pre-hearing conference** shall be held on **September**
9 **18, 2008, at 9:30 a.m.**, at the Commission's offices, 1200 West Washington Street, Conference
10 Room 100, Phoenix, Arizona.

11 IT IS FURTHER ORDERED that all parties must comply with Rules 31 and 38 of the Rules
12 of the Arizona Supreme Court and A.R.S. § 40-243 with respect to the practice of law and admission
13 *pro hac vice*.

14 IT IS FURTHER ORDERED that the Ex Parte Rule (A.A.C. R14-3-113—Unauthorized
15 Communications) is in effect and shall remain in effect until the Commission's Decision in this
16 matter is final and non-appealable.

17 IT IS FURTHER ORDERED that the Presiding Officer may rescind, alter, amend, or waive
18 any portion of this Procedural Order either by subsequent Procedural Order or by ruling at hearing.


