PROCEDURAL ORDER

BY THE COMMISSION:

On January 7, 2008, the Staff of the Utilities Division of the Arizona Corporation Commission ("Staff") filed with the Arizona Corporation Commission ("Commission") a Complaint ("Complaint") against Cienega Water Company, Inc. ("Respondent").

On April 3, 2008, a Pre-Hearing Conference was held, during which the parties agreed to enter into discussions about the resolution of the Complaint.

On May 2, 2008, a Pre-Hearing Conference was held during which Staff requested that a hearing date be set.

Pursuant to a Procedural Order dated May 8, 2008, a hearing date was set for August 5, 2008.

On July 9, 2008, Staff filed its Pre-Filed Testimony.

On July 23, 2008, the Respondent filed a request for a six-month continuance in order to continue its efforts to bring Cienega Water Company into compliance with Arizona Department of Environmental Quality requirements.

On July 23, 2008, Staff filed its Response to Request for Continuance. In its response, Staff opposed the Respondent's request for a continuance.

Pursuant to a Procedural Order issued July 24, 2008, a Status Conference was held on August 5, 2008, to discuss certain procedural issues and to establish a new hearing date.

1 IT IS THEREFORE ORDERED that a **hearing shall be held on October 28, 2008, at 10:30**
2 **a.m.**, at the Commission's office, 1200 West Washington Street, Room 1, Phoenix, Arizona.


3 IT IS FURTHER ORDERED that Respondent shall file with Docket Control a copy of a
4 **Corporate Resolution authorizing Eleanor Stephan to represent the Respondent for the**
5 **purposes of these proceedings by September 5, 2008.**

6 IT IS FURTHER ORDERED that **Respondents shall file testimony and exhibits to be used**
7 **at the hearing by October 17, 2008. Respondent may consult with Staff regarding the**
8 **preparation and filing of testimony.**

9 IT IS FURTHER ORDERED that the ex parte rule (A.A.C. R14-3-113—Unauthorized
10 Communications) applies to this proceeding and shall remain in effect until the Commission's
11 Decision in this matter is final and non-appealable.

12 IT IS FURTHER ORDERED that all parties must comply with Rules 31 and 38 of the Rules
13 of the Arizona Supreme Court and A.R.S. § 40-243 with respect to the practice of law and admission
14 *pro hac vice*.


